Notes:	Father Robert McGuinness was an engineer with the Canadian federal government and the Canadian Pacific Railway before entering the priesthood. After becoming ordained in Rome, Father McGuinness traveled around Europe and his designs for St. Mary's Parish were influenced by the ancient stone churches he visited during his travels.
	The church was known by different names, including: St. Mary of the Assumption and St. Mary's Catholic Church. It is currently called St. Mary's Parish.

Scope & Content:

The Archives General File is an artificial collection of accessions which do not constitute separate fonds or collections or cannot be placed within existing fonds or collections. Included in the collection are textual records of many types, such as manuscripts, reports, letters, diaries, speeches, poetry, plans and others; photographs in the form of prints, negatives, transparencies, albums, postcards, etc.; sound recorded interviews and programmes; and motion pictures. Material pertains broadly to the Banff area and many other areas within the Archives collecting mandate.

Notable items include: Walter Wilcox letter; George Kinney report; interviews with Bill Round and Edward Feuz; original copy of Treaty Number Seven; Mary Schaffer material, including letters, notes, photograph and report; reports on the Nakimu Caves; film pertaining to Banff Winter Carnival; Georgia Engelhard letters and photos; plans for buildings and structures; George Noble photograph; W. S. Park photograph.

History /

Biographical:

Robert Neville (Bob) Smith (1926-2021) was born in Banff. He was the only child of parents Enoch Smith and Laurene Smith (nee Munson). Bob grew up near Lake Minnewanka until 1941, when a hydro dam was installed resulting in the intentional flooding of the area. The family moved to Banff, where Bob met his future wife, Mary Parkinson. The couple were married in 1953 and moved to Seebe, where they raised two daughters, Marjory and Shirley.

Bob worked for Calgary Power Co. (later renamed TransAlta Utilities) from 1953 until his retirement in 1986. In his spare time, Bob founded the Bow Valley Camera Club and the Bow Valley Naturalists organization. In 1999, Bob was part of a successful project with the Bow Valley Naturalists to designate the Mount Yamnuska area as a Bow Valley Protected Area, following 25 years of lobbying with the Government of Alberta. Bob also formed the Meanderthals seniors hiking club in 1993 and led various local hiking trips in his later years.

Scope & Content:

Fonds consists of personal photographs, biographical notes, memoir drafts and other collected materials pertaining to Robert Neville (Bob) Smith. Fonds also includes plans and maps pertaining to the development of land near Lake Minnewanka and the Cascade Power Plant project (1943).

History /

Biographical:

Brewster Transport Company is a transportation company based at Banff, Alberta. Formally organized in 1900 as W. & J. Brewster, Guides and Packers, the company expanded in 1904 into commercial development in Banff and acquired the Canadian Pacific Railway livery concession at Banff in 1905. From 1909 until his death in 1947, Jim Brewster guided the company, with Lou Crosby handling finance. Beginning in 1917, Brewster Transport entered the motorized era with touring cars, later replaced with a succession of buses. From 1920 to 1933, Bill Brewster was general manager and during this period the company acquired Royal Hawaiian Transport and the Sunshine Ski development. The company amalgamated its transportation interests with Rocky Mountain Tours in 1957, and in 1965 the company passed out of the Brewster family's hands, being sold to Greyhound Lines of Canada. Brewster Transport continues to operate as Brewster Transportation and Tours, a diversified transportation and accommodation company in the Rocky Mountains.

Scope & Content:

Fonds consists of textual and photographic records pertaining to Brewster Transport and its predecessor and subsidiary companies. Series are: I. James I. Brewster, 1892-1962; II. Brewster Brothers, 1905-1909; III. Brewster Transfer Company Ltd., 1909-1916; IV. Brewster Trading Co. Ltd., 1907-1926; V. Brewster Hotel Company Ltd., 1909-1926; VI. Brewster Transport Company / Brewster-Rocky Mountain Grayline, ca. 1900-1988; VII. Brewster Transportation and Tours Co. records, 1930s-1996; VIII. Other, 1956-1972.

Series VI is the major series, consisting of 146.5 cm of textual records (and ca.50 col), ca.700 photographs, and ca.100 sets of plans and blueprints. The series includes: Agreements, 1915-1974; Minutes, 1915-1963; Financial papers, 1915-1966; Operating, ca.1900-1988; Properties, 1906-1974; Subsidiaries, 1924-1962; Other, 1943-1977. Photographs, ca.1900-ca.1970, are mainly publicity photographs relating to Brewster Transport vehicles, tours, facilities, Sunshine Ski Lodge and area, Canadian Rockies hotels and scenic views, also Brewster family and Banff personalities; include 2 albums. Plans pertain to properties and facilities.

History /

Biographical:

The Crosby family of Banff and Lake Louise, Alberta, Canada was involved with the development and operation of businesses at Lake Louise from 1923, when Louis S. and Gertrude Crosby built the Lake Louise Trading Company, a general store and dining room. Over the years they acquired Deer Lodge (1924); Triangle Inn, the YWCA and Inglenook Lodge (1941); and operated a gas station (1926). Deer Lodge was expanded in 1925, 1931, 1939, 1941 and staff quarters were added. Gertrude Crosby managed the businesses, while Lou Crosby was involved with Brewster Transport Company from 1907 to 1964. From 1947 until his death in 1964, Crosby was President of Brewster's and prior to that had handled the financial operations for the firm. The Crosby family was actively involved with the Banff Winter Carnival.

Scope & Content:

Fonds consists mainly of business records of Deer Lodge, Lake Louise Trading Company, Inglenook restaurant, including lodge receipts, 1931-1941; accounts, 1929-1934; tourist agency accounts, 1936-1943; menus, 1940-1945; rationing records, 1943-1947; Inglenook advertising, 1958-1962; maintenance and other records. Records were generated during period of ownership by the Crosby family.

Fonds also includes Lou Crosby personal and professional papers and Crosby family papers.

Photographs pertain to Crosby family; Deer Lodge; Banff Winter Carnival; Brewster Transport Company and Jim Brewster; Banff events; winter sports, especially skiing and skating; vacations; scenic views. Photographs taken primarily by Lou Crosby and companions including Byron Harmon, ca. 1910-1950. Photograph album pertains to Lou Crosby's hunting and climbing trips, ca. 1907-1915.

Scope & Content:

File consists of 8 cm of textual records, 65 x 40 cm or smaller. File pertains to the personal and professional records of the Wardle family, particularly James M. Wardle. Records include: birth certificates for each family member (James Morey Wardle, 1888; Leette (Roney) Wardle, 1889; and Dorothy Hope Wardle, 1919); James and Leette's marriage certificate from 1913; proof of age certificates and various notes on family (Roney) history; records pertaining to the family plot in the Old Banff Cemetery (including a photocopy of a blueprint plan of the cemetery grounds); records pertaining to the estates of James (d. 1971) and Leette (d. 1969); miscellaneous family items (including records about Dorothy's cousin Jack Wlliams who died overseas during World War II); photocopies of records pertaining to appointments and certificates for James (including his appointment to Deputy Minister of the Interior in 1935); and James' shares with the Alaska Yukon Pipeline (1966-1967). Records also include newspaper clippings (Banff Crag and Canyon, Calgary Herald) and various correspondence (related to the material) interspersed throughout.
